Microsoft Windows 10 update—your privacy I expect you have heard stories about how, with Windows 10, Microsoft is trying to sell your information to market to you. There are some truths there, but there are also things that can be done to limit the intrusion of advertisements (and how much information is collected), by selecting specific settings in Windows 10. By default, there are also settings in Windows 10 that could compromise your security on wireless networks. Microsoft Windows 8.0 End of Life Microsoft is requiring that users who have not yet upgraded to Microsoft Windows V. 8.1 (from Microsoft Windows 8.0) will be required to do so, as Microsoft stopped supporting Windows 8.0, as of January 11, 2016, so users of Microsoft Windows 8.0 will not receive any more updates to the operating system. If you have a computer running Microsoft Windows V. 8.0, it must be upgraded to Windows V. 8.1 before you are eligible to [take advantage of the free] upgrade to Microsoft Windows V. 10. Users of Microsoft Windows V. 8.0 can upgrade to Microsoft Windows V. 8.1, free of charge, from the Microsoft Store. Microsoft Windows 10 brings back the Start Menu and integrates the "Live Tiles" of the "Modern" or "Metro" interface into the right pane of the Start Menu. *We strongly recommend performing an image backup, before upgrading your operating system!*

Microsoft Web browsers End of Life Microsoft has announced that it has stopped supporting older versions of its Internet Explorer (IE) Web browser. As of January 12, 2016, only the latest version of IE [for a supported Microsoft Windows Operating System] will receive technical support and security updates. This means that Microsoft Internet Explorer V. 9 is [the only] supported [version of IE] in Microsoft Windows Vista and Microsoft Internet Explorer V. 11 is the only supported version of IE in Microsoft Windows V. 7, 8.[1] and 10.

Are you protected against viruses? I have recently visited some clients and found that, although they were under the impression they were protected against current viruses, they either did not have antivirus software on their computer or their subscriptions had expired. Especially nowadays, we need to do whatever we can to protect our information and identities. There are many people writing malicious software designed to damage your computer, hold your files hostage or use your information to make money. Antivirus software and firewalls are needed to help protect you from this malicious software. Beside the free Microsoft Security Essentials (for Microsoft Windows Vista and Microsoft Windows 7) and Microsoft Windows Defender (for Microsoft Windows 8[.1] and Microsoft Windows 10), Comcast and CenturyLink offer free Norton security software, to many customers. LED lamp update In an earlier newsletter, I outlined ways to help decrease your utility bills. One of these was to replace your incandescent or compact florescent (CF) lamps with their LED counterparts. I have found great deals on these LED replacement lamps at Costco . . . often with discounts (I have seen lamps for less than \$2.00 each). Not only have I replaced most all of my lamps with LED lamps from Costco, but have also purchased their LED replacements for 4 foot florescent tubes . . . direct replacements, without needing to rewire your florescent fixture— and they are brighter than the florescent lamps they replaced! I have also replaced my landscape lighting with LED lamps (also using some cool LED RGB floodlights, creating neat color-changing effects). In addition to the LED lamps being more efficient, LED lamps are "instant on" (unlike the florescent lamps) and can be disposed of in the regular trash (unlike the florescent lamps, which must be disposed of at an appropriate disposal center). My experience has shown the LED lamps to far outlast most florescent or incandescent lamps.

Mandatory FAA registration of drones As of December 21, 2015, any new drone, between .55 pounds and 55 pounds, must be registered with the FAA [before flying, outdoors. You must be a minimum of 13 years old to register a drone. Your registration number must be attached to the drone(s). You are required to have a copy of your registration with you, when flying. This registration copy can be electronic. Only one registration is needed, for all drones owned by an individual. You can find more information on requirements and can register your drone(s) at http://www.faa.gov/uas/registration/.

If you do need to run Java, ensure you are using the latest release and remove any old versions.
